Under supervision, such person will be responsible for cases selected by the Deputy Chief Attorney in charge of Special Litigation and Appeals from this docket, which will involve: in-depth legal research; drafting high-quality written submissions such as appellate briefs, motion papers, and memoranda of law; presenting oral arguments before appellate courts; and helping to conclude the litigation to a successful end whether resulting in an order, judgment, or settlement. Qualified applicants are required to have excellent writing, research, and oral advocacy skills, as well as the ability to complete assignments under strict time constraints. Travel to appellate courts within New York State will be required.
