The State Counsel Division in the Office of the New York State Attorney General (OAG) is seeking litigators to serve as Assistant Attorneys General (AAG) in the Judgment Enforcement Team (JET), located in Albany. JET is a new unit within the [Civil Recoveries Bureau](#) (CVB) that is responsible for large-dollar, complex, and high-profile judgment enforcement on behalf of all OAG bureaus. The unit's primary objective is to enforce money judgments, with expert efficiency, and to maximize the recovery of monies owed to the state. By concentrating resources within a dedicated team, CVB will streamline the enforcement process, strengthen deterrence against misconduct, and enhance outcomes for the people of New York.

To fulfill its mission, JET will take the following actions:

- Apply expertise in CPLR Article 52, Debtor and Creditor Law, fraudulent conveyance claims, and all available legal avenues to accomplish its judgment enforcement objectives.
- Investigate and uncover hidden assets.
- Initiate, negotiate, or provide advice on post-judgment litigation necessary to seize or disgorge monies held by judgment debtors, or collaborators.
- Provide litigation support and specialized expertise to other OAG bureaus.

Applicants must reside in (or intend to soon become a resident of) New York state and be admitted to practice law in New York state. In addition, the Public Officers Law requires that OAG attorneys be citizens of the United States. A two (2) year commitment upon being hired is a condition of employment.
