The Office of the New York State Attorney General’s (OAG) [Suffolk Regional Office](#) is seeking an experienced attorney to handle the enforcement of the state’s Cannabis Law in collaboration with the Office of Cannabis Management, as well as affirmative social and economic justice investigations, enforcement actions, and litigation in diverse areas including consumer protection, civil rights, workers’ rights, housing protection, charities. The selected attorney will be involved in all stages of investigation and litigation, including strategic planning, issuing subpoenas, conducting depositions, drafting commencement documents, negotiating settlements, and conducting trials. Additionally, the attorney will initiate and collaborate on statewide initiatives.

The Suffolk Regional Office represents the state, its agencies and officers in state and federal courts in claims and litigation relating to civil rights, public employment, social services, education, elections, law enforcement, public health, state finance, insurance, taxation, and other litigated matters arising out of state operations and legislation. The selected attorney may be required to assist in such litigations.

**Qualifications:**

- At least **two (2) years** of post-graduate legal experience is preferred; however, we will consider well-qualified applicants who have fewer years of experience;
- Prior litigation and trial experience is a plus;
- Strong writing, legal analysis, organizational, interpersonal communication, and problem-solving skills;
- Motivated and collaborative with the ability to work independently and interact with a diverse group of
