New Business

President Baldwin Littman and President-Elect Greta Kolcon commented on the real and perceived conflicts within WBASNY and the need to address and move away from a "mean girls culture" and focus instead on working together to promote WBASNY's mission. Among the ideas are to review and possibly reform WBASNY's nominations process.
