[Everytown for Gun Safety](#), the largest gun violence prevention advocacy group in the country, is seeking an experienced, creative and ambitious litigator to serve as Senior Litigation Counsel, Issues and Appeals, as part of Everytown's growing Litigation and Enforcement Team. The [Litigation Team](#) focuses on developing and implementing litigation strategies to: (1) defend life-saving gun safety laws against Second Amendment and preemption challenges, (2) take on dangerous gun lobby-backed laws that conflict with other constitutional and statutory rights, (3) enforce gun violence prevention laws that are not being implemented, and (4) represent survivors of gun violence seeking accountability and reform of the gun industry's dangerous business practices.

We are looking for a seasoned lawyer who wants to use their litigation skills and public-spirited ambitions to make a difference in our fight for the right of every American to be free from gun violence. Working out of the New York office, the primary responsibilities of the Senior Litigation Counsel, Issues and Appeals, will be (1) taking a lead role in the Litigation Team's growing practice defending cities and counties around the country facing lawsuits challenging local gun safety laws; and (2) working on appeals and amicus briefs in federal and state courts, and, as needed, on trial-level legal briefs and memoranda in connection with affirmative litigation. More generally, this person will share responsibilities for:

- Working with the team to develop and implement Everytown's national federal and state court litigation practice, including research, analysis and strategy development.
- Litigating cases in conjunction with national and local firms and city and county attorneys.
- Drafting and editing memos, pleadings, and appellate and trial court briefs.
- Working on law review articles and op/eds.
- Coordinating closely with other Everytown departments.

Qualifications:

- J.D. and membership in a state bar
- Eight or more years relevant litigation experience
- Meaningful appellate brief writing and argument experience
- Appellate clerkship strongly preferred
- Excellent research, writing, and editing skills and outstanding attention to detail, including an ability to explain complex legal and historical concepts to both legal and non-legal audiences
- Strong interpersonal skills and the ability to effectively collaborate with other lawyers

- Ability to manage multiple projects in a fast-moving environment and deliver timely and high-quality work
- Strong work ethic, sense of humor, flexibility, creativity, and a professional demeanor
- Ability to work in a sometimes-hecktic, open plan office
