Manhattan Legal Services is seeking law students to sponsor for post-graduate legal fellowships such as Skadden and law school funded fellowships to commence in fall 2020. We are part of Legal Services NYC, the largest provider of free civil legal services for low-income people in the country. We are an anti-racist, anti-poverty social justice law office, dedicated to providing high quality legal services in the areas of housing, family law, public benefits, employment, education, consumer, immigration and disability rights, with special units serving particular vulnerable populations. We are committed to working in partnership with community-based organizations in the low-income communities we serve to address the causes of poverty.

MLS seeks proposals to provide direct legal services as well as to address systemic causes of social, racial and economic injustice. We are open to any proposal but some ideas for fellowships include:

- Addressing barriers to employment for people with criminal records and seeking innovative proposals designed to address those legal barriers impeding full opportunities for inclusion in the workforce.
- Working to create wealth in the communities we serve and addressing financial justice issues including access to health care, access to benefits, the ability to transfer wealth, strengthening HDFC's and helping people create and maintain small businesses and microenterprises.
- Working with our HIV and LGBTQ Unit to create a project that addresses one or more of the following areas: access to health care, access to benefits, and other issues particularly affecting LGBTQ youth and transgender women of color.
- Addressing disability rights such as discrimination, mental health issues, and access to housing, transportation and health care.
- Addressing the barriers for marginalized student groups such limited English proficient and LGBTQ students to obtain special education services in a culturally sensitive method and representing them in school disciplinary proceedings related to their special needs
