**Qualifications:** To qualify for an attorney position, applicants must possess a professional law degree (LL.B. or J.D.); be a member in good standing of the bar of a court of general jurisdiction of a state, territory or possession of the U.S.; and have experience conducting federal, state and administrative litigation, which includes developing case strategies; drafting initial pleadings and motions; conducting written discovery and deposition practice; and preparing for and appearing at hearings and trials.
