A minimum of two (2) years of relevant, post-graduate legal experience is required. Substantial experience in the area of fraud and white collar investigations, as well as litigation experience in state and federal courts, is also required. Applicants must possess excellent analytical, writing, research, teamwork, and organizational skills. Experience with securities fraud and/or financial markets is a plus. Prior work experience as a government enforcement attorney or as a prosecutor is also desirable.

Applicants must reside in (or intend to soon become a resident of) New York State and be admitted to practice law in New York State. In addition, the Public Officers Law requires that OAG attorneys be citizens of the United States. A two (2) year commitment upon being hired is a condition of employment.
