      our State Constitution that forces all judges to

                   I think it's a shame that we as a

      state lose so many qualified judges with such a

wealth of experience, regardless of merit or their ability to continue to serve the people of New York. And that's something, as the chair of the Judiciary Committee, I hope to continue to explore this session.

But now on to the nominee before this house. I had the honor, Mr. President, of chairing yesterday's Judiciary Committee meeting, during which we had a substantive and informative discussion with Appellate Division Justice Shirley Troutman. I thank my colleagues on the committee for their thoughtful questions to Justice Troutman, and I also want to thank Majority Leader Andrea Stewart-Cousins and the staff for supporting the committee's work and ensuring the committee and the Senate have sufficient time and resources to effectively deliberate Justice Troutman's nomination.

Justice Troutman is Governor

Hochul's first judicial nomination, and she is an historic one. She will be the second-ever Black woman to serve on New York's highest court, and the only Black woman on the current Court of Appeals.

It's a fitting nomination,

Mr. President, before this chamber with so many Black women leading the way -- of course our leader, Andrea Stewart-Cousins, her chief of staff, Shontell Smith. The Secretary of the Senate is a woman of color. And this is another proud moment in that legacy that has only recently been established.

Justice Troutman is not a native

New Yorker, but she got here as soon as she

could. After growing up in Georgia, she moved to

Buffalo to attend SUNY Buffalo and later got her

law degree right here at Albany Law School.

She immediately entered public service and soon began working her way up the judicial ranks, first becoming a Buffalo City Court judge in 1994, then County Court, Supreme Court, and finally elevated to the Appellate Division. I wish I had that career trajectory. She was elevated to the Appellate Division Fourth Department in 2016.

While this resume is impressive, it only tells part of Justice Troutman's inspiring story. As many know, when the Commission on Judicial Nomination began to examine candidates to present to the Governor, I led many of my

colleagues in calling on the commission to present candidates that had a background in civil legal services or public defense work. The commission did present two candidates with such a background, for which we do thank them.

When Governor Hochul nominated

Justice Troutman, I know that there were many

legal advocates and practitioners that we spoke

to who were initially uncertain about her resume

on paper because it seemed like so many other

nominations they had seen before.

Well, after meeting with

Justice Troutman and listening to our discussion
in committee yesterday, I can assure you

Governor Hochul has made a fantastic choice.

Justice Troutman will be an excellent addition to the bench, and I wholeheartedly support her nomination.

Let me explain to you a bit about what I mean. Justice Troutman demonstrated that she understands the perspective of our state's most vulnerable. She knows what it means to deny someone their liberty, even for a single day. Yesterday she testified that she physically trembled, she said, when she first had to

sentence a defendant to more than 10 years in prison, because she realized, Mr. President, the solemn and terrifying impact the court was imposing on that individual.

Justice Troutman also understands
better than anyone the horrific scourge of racial
injustice that is in so many ways baked into our
legal system, unfortunately. For the last
several years she has cochaired the Franklin
Williams Commission, which educates and advises
decisionmakers in the New York court system on
issues affecting both employees and litigants of
color, and implements recommendations developed
to address these issues.

And I want to also acknowledge the Chief Judge, who is here, for her splendid work in that regard with the commission that she initiated under the leadership of Jeh Johnson.

As part of that work,

Justice Troutman was intimately involved in the development of the recent report that the

Chief Judge commissioned that exposed many ways that our court system disadvantages and disrespects litigants of color. So we expect that work to continue under the Chief Judge's

leadership, along with Justice Troutman.

On a personal level,

Justice Troutman has dealt with racism in the legal system. I was shocked when she relayed the story yesterday of a potential juror that openly avowed that she could not render a fair verdict because of the defendant's race.

I was shocked but, sadly, I'm sure

Justice Troutman has heard it before. While I

and many others would have more than a few choice

words to say to such a person as nonjudges, most

of which are unsuitable for this body,

Justice Troutman calmly recognized the importance

of the person's honesty for the purposes of

building an impartial jury, and she continued to

run the jury selection with professionalism and

poise.

Finally, I want to call attention to one recent opinion Justice Troutman wrote that particularly struck me. In this case, a young woman was being attacked, bullied, in her high school. When a teacher stepped in to break up the attack the young woman, not knowing who the person was, and believing it may have been a second attacker, lashed out with a knife and

injured the teacher.

The young woman was convicted, and by all accounts she acknowledged that her actions were wrong. But when it came time for sentencing, the trial court ignored the recommendations of the defense, the prosecution, and even the victim, and denied the defendant youthful offender status. This young woman was a high school student.

When the case came before Justice
Troutman in the Appellate Division, she
recognized the injustice that this court ruling
would render. She specifically cited the
intersectionality at play in the defendant's
case. She put forward statistics showing that
prosecutors dismissed seven out of every 10 cases
involving white girls, as opposed to only three
out of every 10 cases for African-American girls.

Using these facts and her understanding of what it must be like to be this young woman involved in the criminal justice system, Justice Troutman was able to convince her colleagues to unanimously support her order to reverse the trial court and grant youthful offender status, exercising the court's

discretion in the interest of justice.

I'm certain that Justice Troutman will continue her stellar work on the Court of Appeals. I'm certain that the Chief Judge welcomes her into the ranks of this esteemed body which is so important to New Yorkers at every level. When the time comes, I'll be voting aye on this nomination.

I'm very proud to hereby move her nomination, Mr. President, to the floor. And please recognize, of course, any Senator who wishes to speak on the nomination.

Thank you, Mr. President.

ACTING PRESIDENT BAILEY: Thank you, Senator Hoylman.

SENATOR KENNEDY: Thank you very much, Mr. President.

I rise to support Governor Hochul's extraordinary nomination of one of Buffalo and all of New York's finest jurists to the position of associate judge on the Court of Appeals, the Honorable Shirley Troutman.

Welcome, Judge Troutman, to these auspicious chambers, as well as the Chief Judge

of the courts here as well today.

I want to thank the Governor for putting forward this nomination. I want to thank our great Majority Leader, Andrea

Stewart-Cousins, for moving this nomination to the floor today, and our great Judiciary chairman, who articulated the amazing history and experience, expertise, professionalism and heart that Justice Troutman will bring to the court's highest position.

Justice Troutman has served with distinction throughout her career, from her time as prosecutor in the Erie County District Attorney's office to the New York State Attorney General's office, Assistant U.S. Attorney for the Western District, to her terms on the Buffalo City Court, the Erie County Court, the State Supreme Court and currently as an associate justice for the Appellate Division since 2016.

Her honors and awards speak for themselves: The Outstanding Service to the University and Community by a Non-Alumnus Award from the U.B. School of Law, the Trailblazer Award from the Minority Bar Association of Western New York, the M. Dolores Denman Lady

Justice Award from the Women's Bar Association -and many more, Mr. President, including being
named to the Bennett High School Alumni Honor
Roll for Law, a sign of a Western New Yorker who
continues to make her hometown incredibly proud,
and a demonstration to the thousands of current
Buffalo public school students that they can
achieve great things.

In fact, not only is Justice

Troutman a product of the Buffalo public schools,
but she earned her undergraduate degree at SUNY

Buffalo, a shining example of the merits of our
public education system.

The Trailblazer Award she received from the Minority Bar Association of Western

New York was fitting when she received it back in 2019, and it's even more fitting now, as Justice Troutman will be only the second Black woman to sit on the Court of Appeals. It shouldn't have taken this long. It shouldn't have taken until 2022. But I know that Justice Troutman will lead the way to a much greater diversity on the court that better reflects our state.

Justice Troutman's commitment to justice and the rule of law is unquestioned, and

Western New Yorkers know that she makes her rulings with a fair-minded compassion and empathy that makes it clear how seriously she takes the gravity of her job. It's something the rest of New York State will quickly learn as well.

She's a member of the Ethics

Commission of the United Court System, cochair of the Franklin H. Williams Judicial Commission, and a member of the Advisory Committee on Judicial Ethics, demonstrating that we are elevating someone in our state's highest court who is focused on delivering justice for all.

I think that the great Hazel Dukes of the New York State Conference of the NAACP put it best when she said that Justice Troutman, quote, has lived the experience to ensure she treats all who come before her with compassion, dignity and respect.

It's an incredible honor for me here today, Mr. President, to stand on this floor to nominate -- second the nomination of such an exemplary individual.

And speaking of exemplary individuals, I want to thank the great Appellate Court Justice Gene Fahey for his outstanding

service to our state, and we wish him the best as he begins the next chapter in his life.

To Justice Troutman, her husband
Kenneth, her son Stephen and daughter Lauren,
congratulations on a well-deserved and -earned
appointment. And we know that you will continue
to make your hometown and all of New York State
proud with your work. Congratulations.

Thank you, Mr. President. I'll be voting age on the floor today.

SENATOR RYAN: Thank you, Mr. President.

So Judge Troutman is a Buffalo success story. She's one of six in her family. She was born in Georgia. Her family joined the great migration and moved from Georgia to Buffalo to participate in our booming industrial economy.

In Buffalo when people say "Where did you go to school," they don't mean college, they mean high school. And Judge Troutman is a proud graduate of Bennett High School. She's a Tiger through and through. She went to UB undergraduate, Albany Law School.

These are all really good things, and there's many things that make Judge Troutman uniquely qualified to be on the Court of Appeals. Six years in the Appellate Division. Served on the Supreme Court. Served on the Erie County Court. Buffalo City Court judge.

But I think of all the great attributes that this candidate has,

Mr. President, her time in the Buffalo City Court is what I believe makes her uniquely qualified to be on the Court of Appeals. And her time there gives you a glimpse, gives you a strong idea of the type of justice she will be on the Court of Appeals.

You know, many lawyers view city court as a low-stakes court. Now, while it might be for lawyers, it's not for the people who are appearing in front of that court. Buffalo City Court, it's a people's court. Often it's the only court people ever see, their only interaction with the judiciary. It's where neighbors settle disputes. It's where landlords and tenants go. Low-level criminal cases. It's a court often of down-faced young people and really angry parents. It's a high-volume, often

chaotic place.

And it was there that I first met
Judge Troutman. I appeared in front of her
representing indigent defendants dozens and
dozens of times. These people were having the
worst day of their lives. And in that court,
Judge Troutman somehow slowed things down for
people. She somehow reduced the chaos. And she
treated each defendant with respect. She
carefully explained everyone's rights, how the
process was going to work, and she kept that
level of respect throughout the entire process.

So that's who Judge Troutman is as a person, and that's how she is as a jurist. And I am confident that she is going to be a tremendous asset to the Court of Appeals.

I thank Justice Gene Fahey for his wonderful career in public service. And if you can believe this, being on the Court of Appeals was just one chapter of Judge Fahey's public service.

I thank the Judiciary chair, Brad Hoylman, and Leader Stewart-Cousins for bringing this nominee through the process and to the floor today.

To Judge Troutman's husband Kenneth, to her son Stephen and daughter Lauren, who are with us today in the mezzanine, I say congratulations.

And to Judge Troutman, I say to you the people of Buffalo are proud of you today, and I look forward to casting my vote in the affirmative.

Thank you, Mr. President.

ACTING PRESIDENT BAILEY: Senator

Lanza on the nomination.

SENATOR LANZA: Thank you,

Mr. President.

First, I want to commend the Governor on this outstanding nomination, and I want to thank Senator Hoylman for moving this nomination to the floor today.

I want to briefly say, from one former assistant district attorney to another, it is a distinct privilege and honor to add my voice of support for this nomination.

You know, Justice Troutman's entire career has been characterized by intelligence, compassion, and commonsense. And she possesses an unrivaled grasp of the law. She's eminently

qualified, that is beyond a doubt.

I want to thank you, Justice

Troutman, for taking on this challenge, for
saying yes, for taking this job. It's an awesome
responsibility. There are tremendous sacrifices
to you and to your family. But I want to say, on
the behalf of the people of the State of New
York, that we are so blessed and fortunate that
you are saying yes.

You know, most people in the State of New York really don't know what happens in the Court of Appeals. And that's okay. But when you find yourself before that court, it is probably the most consequential moment in your life. And I know that every litigant and every citizen of the State of New York will be in good hands with you on that bench.

So thank you. When the time comes, Madam President, I will be voting in the affirmative.

ACTING PRESIDENT PERSAUD: Senator Bailey on the nomination.

SENATOR BAILEY: Thank you,

24 Madam President.

The only bad news is that she

goes -- the honorable -- she goes from "Justice" to "Judge." But if you're Shirley Troutman, if you're somebody like her, you know titles don't matter. And if -- the reason why you're in this position, Your Honor, is because titles don't matter to you; the work does.

It is an incredibly fulfilling day for me, as a person of color -- as an attorney of color who has been in courtrooms and seen the lack of diversity, who has experienced the lack of diversity -- to see that we are finally, in the State of New York, amending some of the things that have been so wrong with our justice system and our judicial system for so long.

Your Honor, you represent what is great about our justice system: Diversity of thought, diversity of practice, diversity of experience. Not just you and diversity, but the diversity in the work that you have done throughout your storied legal career. It is no mistake why you're here. It's because of hard work, dedication, diligence, understanding, and an unrivaled legal acumen -- the reason why you're here.

But what you represent is far

greater. What you represent as only the second Black woman to ascend to our state's highest court is something that will resonate not just in my mind, but in the minds of young women and men of color, to see that when you're up there, that they can do that too.

Representation matters. It matters to see people like you in these positions, in decision-making positions, in positions of authority that few if any have ascended to. Your ascension to this position comes with, I would say -- I don't want to say a heavy burden, Your Honor. But I want you to know that my two daughters are going to be watching. And that daughters and sons throughout this state, Black, brown, Asian and white, no matter who they are, they're going to be watching, because of what you represent up here.

Again, it's one of these moments in this chamber that we get to come together as

Democrats and Republicans and those who respect the court system and what judges do, and we get to unite around a common -- not just good, a common great. And that great is you, Your Honor.

My grandparents also did that great

migration with my family. Not from Georgia, from Johnson county, North Carolina. And seeing the possible is something that was always what my grandparents wanted my father and his brothers and sisters to do. And you, you are that possible. The only bad thing -- the second bad thing is that you're not from the Bronx. That would have made this even better.

But you know, Tim Kennedy and Sean Ryan and our Western New York delegation, they get to have a great one in this. And the Governor has made an excellent choice here.

Madam President, I will be voting aye on this nomination when the time is coming.

And Your Honor, I am so pleased that you will be sitting on our state's highest court.

Congratulations.

SENATOR BOYLE: Thank you, Madam President.

I rise, as the ranking Minority
member on the Judiciary Committee, to stand in
strong support of Justice Troutman's nomination
to the Court of Appeals. I congratulate the

Governor on nominating this outstanding nominee.

I'd also like to associate myself with our distinguished chairman Brad Hoylman's remarks about Judge Fahey, thank him for his service, and agree that age discrimination is rampant in this situation, where you can be President of the United States in your seventies and eighties, but not a judge in the State of New York. And I look forward to working to change that with you as well.

I won't reiterate everything that's been -- the wonderful remarks about Justice

Troutman and her outstanding background. She's a person of intelligence and integrity. I've looked at her bio, and I studied, matriculated at Albany Law School at the same time. She's a lot smarter than I am, and that's why I'm glad she's ascending to this high position and I'm right here with you folks.

I think that as a former prosecutor, the minority party is really impressed and hopeful. We have some big issues in criminal justice reform, as we know. Some big cases will be coming up to the Court of Appeals. I know that as a former prosecutor, then-Judge Troutman

will be able to look at not only the rights of the accused, but the rights of the citizenry of New York State to feel safe, as she reviews our laws.

I'll end simply by saying that I believe we had a unanimous bipartisan vote in the Judiciary Committee for Shirley Troutman. That says a lot about the way we all feel about the type of nominee she is. I believe 2022 is going to be a great year for Buffalo, as the Bills win the Super Bowl. But for me as a Jets fan, I'm happier that Justice Troutman is about to become Judge Troutman.

I'm going to support her.

ACTING PRESIDENT BAILEY: Senator Jackson on the nomination.

17 SENATOR JACKSON: Thank you,

Mr. President.

Good afternoon, my colleagues and to all of the guests here today. I rise to explain my support for the nomination of Justice Shirley Troutman to the Court of Appeals.

First let me congratulate the Majority Leader, Andrea Stewart-Cousins, and all of the staff, along with the Judiciary chair,

Brad Hoylman, for moving this process of confirming the nomination of Justice Troutman along with such civility.

And I also want to commend our Governor, Kathy Hochul, and this superb choice in nominating Justice Shirley Troutman to the Court of Appeals.

The decision concerning Justice

Troutman's nomination was easy for me to make.

As some of you may know, Justice Troutman was

deemed highly qualified by several bar

associations and has a long, distinguished career

on the bench. She has invaluable experience as a

prosecutor, trial court judge, and appellate

justice.

Her resume speaks loudly to her qualifications that she has. Before joining the court at the Appellate Division Fourth

Department, she was a justice for the Erie County Supreme Court in the 8th Judicial District, a

Buffalo City Court judge, an assistant

United States attorney for the Western District of New York, an assistant state attorney general, and an assistant district attorney in Erie County.

Given that background, I am happy to vote for Justice Troutman based on her resume and professional conduct. Justice Troutman has proven to have strong concerns for taking due process seriously. And moreover, she is a true champion for justice, diversity, and inclusion.

Her appointment underscores the importance of diversity, as she will be the only judge of the Court of Appeals from Western

New York. And if confirmed by this body, the New York State Senate, she will be the second Black woman to serve on New York's highest court. There is absolutely no doubt in my mind that Justice Troutman is qualified to sit on the highest court in our state.

Yet we also need to talk about the need to ensure greater transparency in the Court of Appeals process. It is my hope and belief that going forward we can ensure that persons appointed to the Court of Appeals will be given greater scrutiny, given the enormity of the court.

We must ensure diversity of work backgrounds by nominating people that have committed themselves to represent all New

Yorkers, and especially vulnerable New Yorkers in the public defense, housing, immigration, court and civil actions. And we must ensure nominees to the court receive individual hearings so that there is ample and sufficient time to ask pertinent and important questions.

We must ensure sufficient time between nomination and hearings and confirmation

We must ensure sufficient time between nomination and hearings and confirmation on the floor so this body, the New York State Senate, and Senators and the public may understand and deliberate the qualifications of each nominee.

These are some of the reforms needed to guarantee a more robust and transparent process for our judiciary.

I have no doubt that

Justice Troutman will faithfully serve the people
of New York on the Court of Appeals, and
therefore, Mr. President, I vote yes to confirm

Justice Shirley Troutman.

ACTING PRESIDENT BAILEY: Senator Ortt on the nomination.

You know, sometimes the things that receive the least attention are the most important things that we do in this chamber. And I don't know if there will be front-page stories about this confirmation, but I really believe that confirming judges, whether it's the highest court or any court, is maybe one of the most important things that we do from an impact on the people of New York.

There will be folks who are in this chamber for two years, four years, maybe longer, but these judges will be in their position for many years, making decisions that have real impacts on our constituents, on New Yorkers, on businesses, what have you, for many years -- maybe decades.

And it's great that we are able

to -- I didn't know -- I don't know Justice

Troutman personally. I had the privilege to

speak to her yesterday or two days ago. She was

very generous to be able to call me, and we went

over her qualifications. And I think that's what

I want to focus on, her qualifications.

I don't know her. I don't know that I ever had the privilege to meet her. But

looking over her qualifications, there is no one that could argue that she is in any way unqualified. In fact, I have seen few judges in my time here that are more qualified or better qualified to sit on this court.

She was a former prosecutor. That's important to me, it's important to a lot of folks. She's been on -- as a prosecutor, of course, as an assistant U.S. attorney, she knows that side of the law. She understands the role of protecting the public. But she's also -- as has been noted, she's had a ton of experience as a judge, as a jurist.

She was put on this path in part by a former member of this house, then-Senator -- or once-upon-a-time-Senator, then Mayor Tony Masiello, someone that I know is familiar with the Western New York delegation here, someone who I consider a friend, someone who I know speaks very highly of Judge Troutman.

And you see all the Western New York delegation here today because at the end of the day we're all kind of homers and we're always going to stand up for one of our own when that's warranted. And in this case it is definitely

warranted.

So I think those qualifications should speak for themselves. I know at various points with different majorities over the years that I've been here, we've had some folks put up for the highest court that I wouldn't have questioned those qualifications, whether they were law professors who had never practiced, whether they had only spent one time on one part or in one aspect of the criminal justice system. But Judge Troutman -- you would want every judge that you were ever before to have her background, to have her grace, her professionalism, and I think her real commitment to administering the law in a fair but firm way on behalf of New Yorkers.

So I wish you, Judge Troutman, all the success. I congratulate you on a very -- a great day for you and your family, a culmination of a great career.

I do want to thank Senator Boyle, our ranker on Judiciary, along with Senator Hoylman and all of the members of the Judiciary Committee for doing their job, which is to actually vet and ask questions. And I think

And every person you touched, from the staff to the members — in the Judiciary where, you know, the incredible Brad Hoylman chairs, guiding that process, having the insightful questions and the answers, the experiences you shared and what you exude as a person and a personality. You are always a professor, you are always that person who came up in your community, who fought and struggled and learned and studied and kept progressing and kept moving forward. You never, ever lost sight of it.

And you touched and taught everyone. You inspired people who aren't easily inspired, because we see a lot, we know a lot, we do a lot -- and quite honestly, it takes a lot to come away from an interview feeling like you got something.

Everyone got something. And today, as we put you in a position where you can shine, we know that you are bringing more than just your historic presence, you are bringing with you the
