Re: Implementation of Mandatory Electronic Filing in NYC Civil Court

Date: July 22, 2021

I am pleased to provide the Bar and other interested persons with an update on the progress of the New York State Courts Electronic Filing System ("NYSCEF"). The Hon. George J. Silver, Deputy Chief Administrative of Judge of the NYC Courts and Interim Administrative Judge of the NYC Civil Court, and the Chief Clerk of the NYC Civil Court, in consultation with Hon. Carolyn Walker-Diallo, Supervising Judge, Kings County Civil Court, have proposed to expand the current e-filing program in the NYC Civil Court to include mandatory e-filing for actions brought by a provider of health services specified in Insurance law Sec. 5102(a)(1) against an insurer for failure to comply with rules and regulations promulgated by the Superintendent pursuant to Insurance Law Sec. 5108(b). Beginning September 29, 2021, the existing e-filing program in the NYC Civil Court will be expanded to include the mandatory e-filing of the above-mentioned case type.

A page has been created on the Unified Court System's website - www.nycourts.gov/rules/efiling/ - to provide notice to the public of proposed new or expanded mandatory e-filing programs and for posting any public comments received on such proposals. The NYSCEF system is intuitive and easy to use, and attorneys participating in our virtual training sessions can receive CLE credit(s) free of charge. Attorneys, paralegals and interested filers may register on-line for upcoming training sessions.

Please note that by legislation and statute all unrepresented parties are automatically exempt from participating in e-filing in any case. However, unrepresented parties may choose to e-file. Information on how to do so is available at http://www.nycourts.gov/e-file-unrepresented. Attorneys who certify in good faith that they lack requisite hardware, electronic connection, or technical knowledge to participate in e-filing, may opt out of e-filing.

E-filing represents an important and necessary advance for the courts and the legal profession in New York State, and continues to be invaluable as we confront COVID-related challenges affecting our courts and the justice system. We thank you for the wonderful support and cooperation you have shown and look forward to continuing to work closely with you as this program moves forward.
