The Office of the New York State Attorney General is seeking an experienced and dedicated attorney to serve as the Deputy Bureau Chief of the [Law Enforcement Misconduct Investigative Office \(LEMIO\)](#) in New York City. Established by Executive Law 75, LEMIO is a first-of-its-kind statewide oversight body charged with identifying and addressing systemic misconduct at local law enforcement agencies, protecting the civil rights and liberties of New Yorkers, promoting accountability and strengthening public trust.

To further these goals, LEMIO investigates alleged patterns or practices and individual instances of misconduct, receives referrals pursuant to Executive Law 75(5)(b), and makes policy and other recommendations. Our most recent annual report can be read [here](#).

The Deputy Bureau Chief will be a critical part of LEMIO's leadership team. Working with LEMIO's Chief, the Deputy Bureau Chief will develop the Bureau's enforcement and policy strategies and help supervise approximately twenty attorneys, analysts and other staff in NYC, Albany and Buffalo. The Deputy Bureau Chief will also work with the Bureau Chief and other LEMIO personnel to build relationships with covered agencies, community stakeholders and experts.
