The selected attorney will handle all phases of litigation from commencement through trial. Trial experience is a must and the ability to manage a large caseload is essential. Excellent writing, analytical, and organizational skills are required. Applicants must have a **minimum of three (3) years** of litigation experience. Federal litigation experience is a plus. **Applicants with substantive Court of Claims or defense litigation experience are strongly preferred.**

Applicants must reside in (or intend to soon become a resident of) New York State and be admitted to practice law in New York State. In addition, the Public Officers Law requires that OAG attorneys be citizens of the United States. A two (2) year commitment upon being hired is a condition of employment.
